Affidavit of Proof

This is an affidavit, sworn by the sovereign on October 18, 2021. This affidavit is being sent to, "*They who are trying to enslave me,*" aka, "*The person I'm not afraid to stand up to*", with a brief explanation of the reasons denoted in this introduction.

I have been made aware of the so-called vaccine and/or mask mandate issued by Joe Biden, the current president of THE UNITED STATES. These so-called masks/vaccines are experimental and have only been approved for testing by the Food and Drug Administration (FDA) under an emergency use authorization.

I am preparing a lawsuit against (name of the person/Company), on the grounds that enforcing a mandate that forces me to wear a mask and/or take a so-called vaccine against my will, is a violation of my unalienable human rights given to me by my Creator. My human rights were not given to me by any government, official, or corporate entity, and therefore cannot be violated by any such entity. In the interest of maintaining fairness and openness on both sides, I will require you answer this affidavit with a sworn liability that all tenets of this so-called vaccine and/or mask mandate, and everything that you are doing in this regard, are lawful according to the original Constitution *for* the United States *for* America as opposed to THE CONSTITUTION OF THE UNITED STATES OF AMERICA established by the Organic Act of 1871. This affidavit will provide you with an opportunity to provide proof, sworn on your liability, that the enslaver has the authority to force me to wear a mask and/or inject or receive/take a so-called vaccine or any other substance, against my will, and therefore, is in violation of my human rights. Having my human rights violated, disregarded, or trampled on is a condition of slavery. I am a slave to no person, no law, no government, or any other entity whatsoever. According to the 13th Amendment to the Constitution *for* the United States *for* America, "Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction." I wish to settle this matter peacefully and without any drama or fanfare, but if you refuse to answer this affidavit with proof of every point and swear on your liability that all of your answers are true and correct, I can make this public and I can sue the listed enslavers for a number of reasons. Those reasons include forced compliance(slavery), crimes against humanity and my human rights, and any other reason deemed reasonable by myself and my legal assistance. Only the person mentioned in this affidavit can satisfy the conditions of this affidavit by providing proof of the claims set forth herein. If each proof is not proven, point for point, in the time allotted, then you will be considered in default and I can file a criminal or civil suit using this affidavit as evidence that you have violated my human rights and have therefore caused me harm.
