

Notice to the agents or staff of my enslavers, is notice to the principal. You are hereby given 21 days to answer this affidavit. To settle this matter peacefully, you must prove the following proofs INCLUDING PROOF THAT MASKS WORK:

1. Prove that the SARS CoV-2 virus has been isolated by the Koch Postulate process used to identify viruses. This proof must be verified by professional labs that include samples from a living or dead person who is said to have COVID-19, that do not contain anything but the isolated SARS CoV-2 virus.
